People Helping People: The Volunteer English Program of Chester County Wednesday, November 9th *Grove United Methodist Church* 7 p.m. Networking and Nibbles 7:30 p.m. Program

This month's AAUW program will feature Linda Grosse, Executive Director of the Volunteer English Program of Chester County. Linda will explain how this almost-all-volunteer program has been able to change the lives of non-English-speaking adults in Chester County. Also speaking will be Sandy Kwisz, a VEP tutor and a longtime member of our AAUW branch, along with Elizabeth Kwisz, her daughter.

In recent years, the number of non-English-speakers has burgeoned in our county, and newcomers are eager, contrary to some popular beliefs, to learn to speak our language. Unfortunately, because so many of these newcomers are here due to harsh economic circumstances, they must work every spare hour they have and often cannot afford tutoring or classes in the English language. And without knowledge of English, these newcomers are at a distinct disadvantage when they attempt to find work, housing, transportation and avail themselves of the many services they need. This is especially true for parents of children who are in our public schools and who must know how to communicate with teachers and other education providers.

The VEP program has produced many touching stories during its existence – come and be inspired by both the tutors and the stories about foreign-speaking clients who have made great strides while participating in the VEP. You will long remember the courage and hard work of some of these hopeful participants!

Guidelines for AAUWSUM

1. Deadline for articles is the 10^{th} of the month unless noted in newsletter.

2. Board will develop outline/plan for newsletter.

## It's My Vote: I Will Be Heard – Voter Education And Elections News

Ninety-Six Year-Old Woman Denied Voter ID Card Because She Didn't Have Her Marriage License

This year, Tennessee followed several other states to pass a voter identification law that will go into effect for the 2012 election. Voting rights advocates and civil rights groups, such as the NAACP and ACLU, oppose voter identification laws because they marginalize poor, elderly, and minority voters who are less likely to have government-issued photo IDs. One such example has recently occurred: Dorothy Cooper, a 96-year-old Chattanooga resident, was denied a voter ID card for failing to produce her marriage license.

Cooper wanted to ensure she would have the necessary ID to vote in next year's elections. She provided a rent receipt, a copy of her lease. her voter registration card and her birth certificate. Typewritten on the birth certificate was her maiden name, Dorothy Alexander. The clerk denied Cooper her free ID at the Cherokee Boulevard Driver Service Center because she did not have her marriage certificate, which would document her legal name change. Cooper doesn't have a driver's license because she never learned how to drive. Under the Tennessee law, until she produces a certified copy of her marriage license Cooper will not be able to vote at polls on Election Day 2012.

AAUW believes it is vital for everyone, especially women, to be able to vote. AAUW is proud to launch a serious investment in getting out the women's vote for the 2012 election. Through the campaign, *It's My Vote: I Will Be Heard*, we will work to educate women across the country about the rights and privileges that are at stake in the upcoming election. We will increase the volume and direction of women's voices and commit ourselves to getting women to the polls in record numbers.

## In Review - Marcellus Shale Natural Gas Extraction Presentation By Peggy Staarman

"Though she be but little, she is fierce." (A Midsummer Night's Dream, Act 3) During the AAUW October meeting, diminutive Roberta Winters revealed her passion about protecting Pennsylvania's interests concerning the Marcellus Shale natural gas extraction. Her very informative presentation entitled "Rock and Roll" gave an overview of the history of this underground rock formation and the development of the fracking technology that has evolved over decades to extract the gas from the shale.

Although natural gas is a cleaner, carbon-based fuel that may promote energy independence, provide jobs, and generate revenue, the extraction of the gas could have significant impact on Pennsylvania water resources, air quality, the economy, and the land itself. The League believes that Pennsylvania government policies should promote the protection and wise management of natural resources since they are the common property of all Pennsylvanians.

Ms. Winters ably addressed many questions and urged each of us to take a position after examining the facts. She encouraged AAUW members to contact their legislators to ensure transparency in all stages of production, to establish oversight, to encourage a sufficient fee structure on gas extraction, and to protect public health and the environment.
