"Dear AAUW West Chester-Chester County (PA) Branch.


I hope this finds you all safe and well! I'm reaching out to share that your branch achieved a star for the Communications & External Relations area of the Five Star Recognition Program.

The Resource Pantry at West Chester University

Our branch once again stepped up to support the students served by the WCU Resource Pantry, collecting \$535 in gift cards as a special holiday gift! Each year we collect gift cards for the recipient of our Gateway to Equity Award. With the restrictions and limitations of the COVID pandemic, I wasn't sure if we could collect as much as before, but in fact, our contributions exceeded that of previous years!

There are 24 Promise students on campus over the winter break, students who came out of foster care, without families to care for them during vacations. There are about 170 other students on campus for various reasons. The dining hall stopped serving meals on November 30. To make matters worse, the director of the Pantry recently resigned, leaving the job to the director of the Center for Civic Engagement and Social Impact, Dr. Seth Jacobson. I met Seth when I dropped off the first of our gift cards, and he told me he is in the process of reorganizing the management of the Pantry. He was extremely grateful for our long-standing support.

The following information comes from him:

 As of November 30th (when the campus transitioned to full remote operations for the remainder of the fall semester and through the winter break), the dining halls and standard food services became unavailable. To support food insecure students over these weeks, the Pantry implemented Operation SNOW – and will remain open 1 day a week:

- Operation SNOW (Student Needs Over Winter): Back in October, we launched this collection campaign to ensure that our Promise Program students have up to 8 weeks' worth of food and personal care supplies. On November 19th, donated food and personal care items were packaged and delivered to the residence halls. This year, we had a surplus of donations for Operation SNOW. Therefore, the packages are available for other students (with need) living on campus to pick up, as well.
- We are also preparing to launch a new program next week that will provide select students with gift cards to local grocery stores that provide delivery services.

Many thanks to all of our generous contributors for providing these special treats for the students. Knowing that someone cares is just as important as the gift card itself!

Laundromat Library League: Book Drive Delivered Over 400 Books

Our wonderful members contributed over 400 books as a result of the November Book Drive. They also contributed \$595 so that the LLL can buy books in Spanish and those featuring minority characters.

Arlene reports LLL has been getting books to many sites, including some in New Hampshire, Illinois, California, and Arizona. (The latter are in Navajo County, Arizona's poorest county and home to many Native Americans.) We have many sites in Pennsylvania and recently got full new boxes to two sites in West Philadelphia and other areas. In this area we distribute books to children in other ways than just laundromats. Examples include families served by the Spanish Health Ministry in Kennett Square (where gift packets are handed out by staff), and mothers who have been rescued from trafficking and reside in Dawn's Place.

TWO MEMBERS PASS



Rachel Cochlin Mullin, 89, a volunteer who worked for her community, women in politics and people with disabilities, died Saturday, November 21, 2020. She was born on Amethyst Farm in West Chester to James Joseph Cochlin and Martina Coyle Cochlin.

Rachel attended St Agnes school for 12 years and went on to the Philadelphia College of Pharmacy and Science where she graduated with a BS in Pharmacy, one of only a few women to graduate in 1953. She went on to be a role model and to foster the love of pharmacy practice in her son and two of her grandchildren, who also graduated from pharmacy colleges. She practiced as both a community pharmacist at DeHaven's Pharmacy in West Chester and as a hospital pharmacist at Chester County Hospital.

Rachel was committed to improving her community and devoted her talents to many good organizations. She was a member of the East Bradford Township Planning Commission for 20 years and served as vice chair. She was member of the West Chester Area Municipal Authority Board from 1971 through 1998. She was also on the board of Embreeville Center.

Rachel continually supported other women to achieve their goals. She was past president and board member of the West Chester branch of the American Association of University Women. She was awarded AAUW's "Woman of the Year" in 1990.

She was a Democratic committee person in East Bradford Township for many years and supported women in politics. Rachel ran for the office of Chester County Commissioner and served as campaign treasurer and campaign chair for other women political candidates. Rachel was an early advocate for people with disabilities. She demonstrated this by serving as a board member of the Chester County Association of Children with Learning Disabilities. She also was an officer for the Delaware Valley Society for Infantile Autism.

Marian Elliott Stevenson

Marian Elliott (nee Irvine) Stevenson, died on December 5, 2020. She is survived by her husband, Robert W. Stevenson, Sr. and two sons, Robert Jr (Louise) and Eric R., a brother, R. Allen Irvine (Ann), cousins, nieces, and nephews.



She graduated from Lower Merion High School. Ardmore, PA. She received a B. S. in Business Teaching from Drexel Institute of Technology and when typewriting became keyboarding, she went back to school for a M.S., in Library and Information Science at Drexel University. She was a member of Alpha Sigma Alpha, American Association of University Women, ALA and PA Library Association. She was a member of Magic Needles, Bible Study, Book Discussion and Church Librarian at Westminster Presbyterian Church, West Chester, PA.

Members of our AAUW chapter remember Marian for her commitment to her community, her devotion to education, and her many interests as a member of our chapter. She will be missed.

LLAP Members Publish OpEd Piece on Gerrymandering

On December 18 the Daily Local News published an Op Ed piece written by Sarah Caspar, Marie Knox, Barbara Lathroum, Deb Liczwek, Karen Moynihan and Jean Speiser, all of whom are members of our AAUW chapter's LAPP (Legislation and Public Policy) committee. All six are involved with LAPP's gerrymandering initiative and wrote because unless and until the procedural rules change, no gerrymandering reform will be passed in Harrisburg in 2021. The members urge you to write both to your state representative and your state senator, urging reform of the procedural rules before anything else is addressed in the new state legislature. Here's the text of the Op Ed piece:

We support reforms in Harrisburg. Every new legislature's first task is voting on procedural rules. These rules usually hand control of all legislation to a very few people who get complete power to decide what bills will be presented to the House or Senate.

If they do not like a bill, it goes nowhere and never comes up for a hearing or a vote. Our local legislators have their hands tied. They cannot vote a bill out of committee to discuss it on the floor without the approval of the leaders.

Pennsylvania has one of the least productive legislatures in the country, passing only five to seven percent of the bills introduced each year. Even bills that have majority bipartisan support have a hard time making it out of committee.

One example is "Victoria's Law," intended to prevent pet stores from selling puppy mill dogs. This bill took many months to get a hearing and still hasn't passed. A less popular bill has almost no chance of a hearing, let alone a vote, even when there's broad support.

If fairer rules applied, members of both parties would have more say in what gets voted out of committee and discussed by all the legislators. The only way to prevent just a few legislators from hijacking the process is to stop these restrictive rules.

Please contact your legislators today to urge them to vote against the usual restrictive rules when Pennsylvania's House and Senate reconvene in January, and to support rules that will allow our legislators, whatever their party, to have a voice in the passage of new bills. Masks, Masks, and More Masks!


