## AAUW Membership question

Do you have a friend that would be a perfect fit for AAUW? Someone who believes passionately in equity for women and girls and would love to work toward that goal? But you can't invite her to join us because she doesn't have a degree?

I've spoken to many friends in our club, and most have said they have such a friend. The mission of our organization is to provide equity for all women, not just those who have had an advanced education. At one time the issues for collegeeducated women were different. Women with degrees were unable to get credit and unable to make a variety of financial decisions without the approval of their fathers or husbands. Certain careers were off-limits. Female doctors, engineers, and lawyers were extremely rare. Think of the battles of Ruth Bader Ginsburg to be taken seriously. Educated women banded together to lobby for change.

Today we still face glass ceilings, although many have been broken. Pay equity is elusive, and overall, women are paid less than their male counterparts. Think of the struggle by women soccer players, who earn a fraction of what their male counterparts get for their accomplishments. Our focus has shifted to include the struggles of all women. In doing so, our (*continued on next page*)

organization finds itself in the awkward position of demanding change for women that we refuse to accept as members. It's no wonder we are seen as an elitist club by prospective members and by wealthy foundations that once supported us.

It's time to invite these women into AAUW. Let's embrace diversity and welcome women of all

walks of life into our group. The criteria for membership should not be whether someone has had the good fortune to attend college, but whether they want to join with us to promote opportunities for women.

AAUW National will ask for your vote on this membership issue this spring. I urge you to vote for change in our membership requirements!

## March Branch Meeting: The Art Scene in Chester County

#### Jeff Schaller, Chester County Artist

I create textural art pieces which incorporate representational form with the printed word. In essence, the visual and written symbols merge to create a unique aesthetic language that is both provocative and whimsical. My multipleimage pieces, with images ranging from polka dots to popular culture, evoke emotions and memories in the view. The combination of images tells a story and provokes a personal exchange between the art and the audience.

Jeff Schaller, Chester County artist and art enthusiast, spoke at our branch meeting on March 10 about visual arts in Chester County. He started with a very brief explanation of the most commonly used media: oil, acrylic, encaustic, and watercolors. After a nod to the artists whom he referred to as "the big three," meaning Andrew Wyeth, Horace Pippin, and Harry Dunn (although his name may be less familiar to the public than Wyeth and Pippin, Jeff credits Harry Dunn with designing the NBC peacock), he told us about Chester County artists who are not so well known.

Jeff first mentioned artists who have achieved some recognition: Tom Bostelle, Adrian Martinez, Robert Jackson, and Teresa Haag. They paint in a variety of styles and techniques ranging from whimsical to realistic to experimental. Jeff has always been interested in promoting the work of local artists and conceived of opening artists' studios to the public one day a year. This year 144 artists are participating at 59 studios. Although most of the works are flat things you can hang on a wall, there is also sculpture, jewelry, and furniture.

There is no charge to visit any or all of the studios and art prices start at \$75.00. Even if you are not interested in buying, the tour provides an intimate glimpse of studios that would not otherwise be open, and an opportunity to see a remarkable range of artists and their works in a short time. It's also enjoyable simply to visit the studios and to drive through parts of Chester County that may be unfamiliar. Some are in the artist's house, some are in separate buildings, and some are in a Spring City location designed specifically for artists.

Studios are located throughout Chester County with the heaviest concentration in West Chester and nearby areas. The Studio Tour also provides the possibility to buy original art at a fairly low price and to support local artists. All works are framed and ready to hang. The Tour this year is scheduled for Saturday and Sunday, May 15 and

The Art Trust, and the Chester County Art Association, all in West Chester, as well as Gallery 222 in Malvern, the Square Pear Gallery in Kennett Square, and the Street Road Gallery in Cochranville.

Jeff is passionate about promoting local artists and it was a pleasure to have him share that with us. His motto might well be Shop Local, Buy Local.



## Laundromat Library League Update

Our West Chester-Chester County Branch of AAUW has been a supporter of the Laundromat Library League (LLL) for many years. As you may know, one of our members, Arlene Rengert, is a co-founder of the LLL. Our branch has sponsored book drives and fundraisers for which the LLL has been extremely grateful. The LLL's mission is to supply books to children who may have few or no books at home. We place decorated boxes of books in laundromats so that children may read them there, take them home, and share them with others. Each book has a sticker in English and/or Spanish affixed to the front cover that says, "Read It. Love It. Pass It On."

Despite the difficulties presented by the pandemic, most of our sites have been maintained. We have encouraged all stewards of the sites to continue serving the laundromats only if they were comfortable. In addition, we have added new laundromats including eleven new sites in our area. We have also had inquiries and successes from other places in Pennsylvania such as Lancaster and Lebanon and other states.

Recent book drives have replenished our supply of books. Of course, our own branch donated 422 books and \$495 towards the purchase of new books this past fall. Boyertown Library donated 899 books, Montessori Schoolhouse in Springfield, IL gave the LLL 258 books, the BlackRock Corporation in partnership with the Wilmington Library donated 200 books, and a Downingtown East High School Student through his SOAR (Spread of Active Reading) podcast collected 1600 books for the LLL. We appreciate these book drives so much because the demand for books is constant with over 200 sites in over 30 states. We especially value the donation of monetary funds that allow our teacher teams to search for special promotions that offer books under \$2.00 in Spanish and/or with multicultural themes.

We treasure your enthusiasm and support for the LLL so much. Our hope is that many young children will enjoy the books and develop a lifelong love of reading.

## **Our Voice Should Be Heard**

Submitted by Peggy Staarman Black Women of Chester County in Action is partnering with Chester County Marching Forward again to continue their nonpartisan effort to empower underserved women in Chester County. The steering committee has identified three goals this year:

- 1. <u>Empower voting</u> Many underserved women are unfamiliar with the voting process and need information about the mechanics of voting such as eligibility, election dates, the difference between a primary election and the general election, polling locations, the procedure of voting, and so many other issues.
- 2. <u>Education</u> Voters should know who the candidates are, their position on issues, the ballot composition, the impact of local elections on their lives, and other matters.
- 3. <u>Encourage participation</u> Participating helps increase knowledge of the voting process. Voters should be urged to be election volunteers and, ultimately, to run for office.

The steering committee led by Cheryl Miles recently invited representatives of community organizations to share ideas to expand and achieve the three goals. Representatives from the NAACP, Chester County Food Bank, the Maternal and Child Health Consortium, the League of Women Voters, Alianzas de Phoenixville, Volunteer English Program, and West Chester-Chester County Branch of AAUW were just some of the community organizations who joined the Zoom meeting. There were also some Chester County officers who participated such as Clerk of Courts Yolanda Van de Krol and Sheriff Fredda Maddox as well as interested individuals from the community.

After another steering committee meeting, participants will be asked to join a future Zoom meeting to discuss the presented ideas and to formulate an action plan. **If anyone in the branch would like to join this initiative**, please contact Peggy Staarman, a member of the steering committee, at <u>peggstaar@verizon.net</u>.

# ERA Advocates Focus on Senate and First 100 Days

by AJ Conroy, ERA Illinois, submitted by Arlene Rengert At the start of 2020, Virginia became the final state to ratify the Equal Rights Amendment. The resolution went to the National Archivist for certification. This ministerial task is proscribed by federal statute and this process was followed by Nevada, Illinois, the archivist and every state that ratified the "Madison Amendment" in the 90s. This time, a lawsuit prevented that from happening.

Although the original lawsuit, brought by Alabama, South Dakota, and Louisiana, was voluntarily dismissed in March, legal wrangling continues with two parallel lawsuits against the Archivist—one brought by private parties and the other between states. Meanwhile, The US House of Representatives voted to remove the time limit for ratifying the amendment.

At this point, there are three possible outcomes: (continued on next page)

- Congress votes to remove the time limit, and the Supreme Court defers to Congress using the political question doctrine.
- The Supreme Court acknowledges the 28th Amendment as proper through Article V.
- The Supreme Court decision dismisses the case, and advocates must restart the ratification process.

What can advocates do now? Email your senators about the resolution to remove the deadline. SJRes1 is co-sponsored by Senators Lisa Murkowski and Ben Cardin.
