Ahoy! Cindy Knisley's Sailing Adventure on the Kalmar Nyckel

(abridged from an article by Cindy)

It was a blustery day in January 2022 when the message popped up on my screen.

"Volunteers needed. Help sail a 17th century squarerigged ship. No experience necessary!" I decided to inquire and quickly became hooked, attending weekly training sessions, both on zoom and at the shipyard in Wilmington, DE. But wait Let me explain. The subject of this story is a tall ship known as the Kalmar Nyckel, a Dutch armed merchant vessel that in 1638 sailed from Kalmar. Sweden, to the Christina River, not far from the present-day skyscrapers of Wilmington. Here the sailors established the colony of New Sweden. The sailors befriended the local Lenape Indians and engaged them in the exchange of metal tools, duffel cloth, and beads for beaver pelts, much needed in Europe at the time. After four successful trans-Atlantic crossings, the original Kalmar Nyckel sank in a battle off the coast of Scotland.

Three hundred years later, in 1938 President Franklin Roosevelt dedicated the park known as Fort Cristina, honoring the Swedish queen at the time. As interest grew, a recreation of the original ship was designed in 1995 and constructed in the Wilmington shipyard. Thus began the work of the Kalmar Nyckel Educational Foundation.

Well, back to that January day in 2022 . . . Crew training was a challenge, from tying more knots than I had ever imagined to figuring out the eight miles of running rigging on the ship. We even had midterms and finals on seamanship. A few times I

wondered whether this endeavor was a good fit for me after all, but I didn't give up. Finally, we trainees completed the requirements and received a blue shirt, plus the privilege of signing up to volunteer! I quickly found my bliss in the ed sail department, teaching small groups of school children about "Setting the Mizzen on the Quarterdeck" or "Life of a Sailor," among other topics.

A unique opportunity unfolded and I signed up for a summer voyage. This adventure included climbing onto and off the ship on narrow exterior steps, sleeping in a tiny berth where my belongings for the week were also stowed, pulling mooring lines, and cleaning the floors when assigned to "sweep and swab." I loved the education events during public sails in New London and Mystic Harbor, Conn., and smile today just thinking of my pirate costume and the marlin spike and knife dangling on my belt. The most amazing feat of the voyage was hauling our beloved ship into dry dock for routine maintenance. That's a story for another time! But rest assured, she is in "ship shape" condition and back at home in Wilmington, sailing and teaching guests about a bygone era.

Subject: PA Governor Candidates - Election Integrity Platforms

Context: Understanding the candidates' platforms on Election Integrity is helpful in preparing for the November general election. This information was gleaned from the candidates' websites. Summary:

Mastriano:

- 1. Eliminate no excuse mail voting and ballot drop boxes.
- 2. Enact universal voter ID for those who go to the polls.
- 3. Increase the number of poll watchers.
- 4. Immediately end all contracts with compromised voting machine companies.
- 5. Appoint a Secretary of State with experience in securing elections from fraud.
- 6. Ban the use of private funds to influence elections.
- 7. Make millions of registered voters register again.

Shapiro:

- 1. Veto any efforts to restrict mail voting.
- 2. Expand early voting.
- 3. Set up automatic voter registration.
- 4. Make funds available so that every county can conduct a post-election analysis through a risk-limiting audit
- 5. Allow counties to pre-canvass mail ballots before election day to reduce delays in reporting election results.

Context: Understanding the candidates' platforms on the economy is helpful in preparing for the November general election. This information was gleaned from the candidates' websites.

Summary:

Mastriano:

- 1. Expand natural gas extraction efforts in the Marcellus shale region
- 2. Withdraw from the Regional Greenhouse Gas Initiative, a consortium of 11 states that aims to cap and reduce carbon dioxide emissions from the power sector.
- 3. Lift regulations, taxes, and fees that impact drilling and mining for fossil fuels.
- 4. Reduce regulations that are hurting the state economy.

Shapiro:

- 1. Create hubs that connect businesses, universities, and research institutions as a way to create jobs.
- 2. Expand Manufacturing PA Initiative train a skilled workforce by embedding students with local manufacturers and provide technical support to PA Manufacturers.
- 3. Cut corporate tax rate to 4% by 2025.
- 4. Aggressively push to make PA the home of a new regional hydrogen hub and grow carbon capture, utilization, and storage industry.

Context: Understanding the candidates' platforms on reproductive rights is particularly critical for women and girls and helpful in preparing for the November general election. This information was gleaned from the candidates' websites.

Summary:

Shapiro:

- 1. Committed to veto any bill that would restrict abortion rights
- 2. Expand access to reproductive care.
- 3. As Attorney General has supported protection or expansion of abortion rights and argued against the Trump administration gag rule that barred funding for clinics that made referrals to or informed patients about abortion providers.

Mastriano:

- 1. Supports instituting a full ban on abortions without exceptions for rape, incest, or instances where the mother's life is jeopardized by the pregnancy.
- 2. Would sign a "heartbeat bill" that would ban abortion at 6 weeks.
- 3. End state funding to Planned Parenthood
- 4. Support funding for counseling and for adoption services.
- 5. As a state lawmaker, introduced his own "heartbeat bill".

Context: Understanding the candidates' platforms on crime is helpful in preparing for the November general election. This information was gleaned from the candidates' websites. Summary:

Shapiro:

- 1. Stop imprisonment for technical rule violations. Reinvest money spent on that imprisonment into initiatives and programs to get violent criminals off the streets.
- 2. Fund legal representation for indigent Pennsylvanians in first budget (PA is the only state in the country that allocates \$0 to public defenders' offices).
- 3. Oppose mandatory minimum sentences and that those convicted of 2^{nd} degree felony murder are not given life sentences.
- 4. Support bills that create opportunities for elderly prisoners no longer deemed as threats.
- 5. Advocate to abolish death penalty and legalize recreational marijuana.
- 6. Focus on funding local police.

Mastriano:

- 1. No published plan to lower crime on his website although has stated it is too high.
- 2. Minimum sentence of 25 years in prison for fentanyl dealers whose sales lead to overdose deaths.
- 3. Protect police from "social justice warriors" so law enforcement personnel won't be prosecuted for a "split second decisions"
- 4. Send state police to round up undocumented immigrants and take them to President Biden's Delaware home.

Subject: PA Governor Candidates – Tax Platforms

Context: Understanding the candidates' platforms on taxes is helpful in preparing for the November general election. This information was gleaned from the candidates' websites.

Summary:

Mastriano:

- 1. Eliminate property taxes for all homeowners
- 2. Establish working groups to slash gas tax and reduce the corporate net income tax rate.
- 3. Create teams at each state agency to cut statewide regulations by 55,000 in the first year.
- 4. Pass legislation that would automatically review all regulations with a cost of more than \$1 million, eliminate two regulations for every new regulation created, increase transparency for permit process and expedite reviews.

Shapiro:

- 1. Issue gas tax refunds for every personal passenger registered in the commonwealth (up to 4 per household).
- 2. Eliminate state gross receipt and sales tax on cellphone service (11%).
- 3. Expand property tax and rent rebate program by increasing maximum rebate to \$1,000 and expanding eligibility to 275,000 more people.


