## FEBRUARY IS HEART MONTH – Refresh Your CPR Preparedness!

Many of you know I volunteer at Longwood Gardens in the Meadow Garden. A couple of weeks ago one of my Longwood meadow garden team members collapsed in cardiac arrest on the trail in the meadow. Our team of 6 people did CPR until the emergency personnel arrived, helped the emergency personnel find us, assisted with using the defibrillator AED device, etc. Fortunately our teammate survived and is doing well. The Longwood Fire Company conducted a debrief with us and we learned how lucky we and our teammate were; the promptness and correctness of our actions saved him, making him one of only 1-3 out of 10 who survive such an event.

The debrief, as well as my thoughts recurring in any case after the event, has prompted me to promote awareness of emergency preparedness. My own CPR training was a while ago and out of date. Newer standards focus on chest compressions only, without necessarily including mouth to mouth breathing ("Hands Only")—the highest importance is to keep the blood circulating to the brain, and even without breathing the blood retains some oxygen. I also had never worked with an AED defibrillator device.

I stopped at Uwchlan Ambulance, my local ambulance company, and spoke with Beth McCall, their training coordinator, about CPR training. February is Heart Month, and they are promoting CPR training (SEE BOX).



## JANUARY PROGRAM: Artificial Intelligence (AI) and Biased Hiring – Resume Scanning Algorithms, Scanning of One-Way Video Interviews, and Video Games



Lori Andrews,
University Distinguished
Professor of Law at IIT
Chicago-Kent College of
Law and Director of IIT's
Institute for Science, Law
and Technology,
explained to our January
11 AAUW Zoom

audience how for a wide array of jobs employers use artificial intelligence and machine learning rather than humans to screen applicants.

Ms Andrews pointed out that 407 Fortune 500 companies use AI-based hiring technologies, including resume-scans, one-way video interviews, and video games, to screen applicants. Claims are that AI tools are supposed to decrease costs, save time, identify the best applicants in the hiring process, and avoid racial and gender discrimination. However, algorithms used in these technologies are often based on "hiring more people like those who are successful in the companies," and often more of those are men than women. She noted that in 2018, men accounted for 81% of Microsoft's technical workforce, 79% of Google's, 78% of Facebook's, and 77% of Apple's – so discrimination occurs with AI.

Ms Andrews pointed out the problems in creating AI for hiring, especially identifying what qualities are essential to success, how we measure these qualities, and how can these measures be used to identify best candidates. "Football players are not

necessarily good CEO's, despite their 'Success'," she noted. She noted pitfalls with resume scanning tools, especially because women often use more collaborative and less assertive language than men, and resume gaps may be unapplicable. Traits used in one-way interviews also may suffer from male bias. Video game assessments seem even less useful; she noted that "it is hard to imagine how things done in these often simplistic games can predict job performance or identify truly useful qualifications."

It appeared from Ms Andrews' presentation that legal recourse is limited, with the need to prove disparate treatment or disparate impact. Proposed policy solutions that are being enacted in some states are helping, by requiring a) disclosure (i.e., the company must tell you AI is analyzing face video), b) non-discrimination (requiring a company to prove its AI is not biased), and c. ban (for example, 24 states and municipalities ban companies from asking past salary history, which often hurts women, or using AI based on maledominated data).

She noted also that data is helping, by showing that having a mix of women in top levels has a financial advantage, and that gender diversity is a big engine for innovation.

It was startling to learn from her presentation some of the tools we women may not know are being used to evaluate us for hiring (video games?!). Awareness is one tool women have.

#### **AAUW West Chester-Chester County Featured in Hershey's Mill Guide and Digest**

Thanks to Marie Knox, editor of the Hershey's Mill Guide and Digest, Janet Kane was invited to submit an article highlighting the work of AAUW West Chester-Chester County. With editing by Cathy Palmquist, the article appeared in the January issue. It was entitled: AAUW – Advocating for Women and Girls and gave a comprehensive overview of AAUW and our branch including: the history of our organization, its mission and specific ways in which our branch has supported goals relating to education, advocacy, philanthropy and research. Our upcoming programs for the remainder of the year were featured as well as a list of our special interest groups. The article concluded by inviting readers to join the other seven Hershey Mill residents who are already members of our branch in becoming members of our branch. The GREAT NEWS is that Kim Glavin has already received two calls from prospective members. Following is an update on the Laundromat Library League forwarded by Peggy Staarman from the LLL Board; members might be interested in seeing it because of the many years our AAUW branch has supported the LLL!

These highlights do not even call into view the collecting, sorting, maintaining the storage area, connecting with stewards, replacing and replenishing the boxes that goes on quietly every day. To all who made 2022 a success for the Laundromat Library League – **Thank you!** 

- As always, the year proved a busy one for the volunteers of the Laundromat Library League. At least 8 new sites were recorded, 3 in New Jersey, 2 in Newtown Square, PA, 2 in North Carolina and one in Florida.
- Significant grant funding was secured from Justamere Foundation, Constellation Energy, Chester County Community Foundation and the American Association of University Women.
- The diversity of ages of our volunteers continues to impress: Malvern Prep high school students have recently adopted sites for stewardship; 40- and 50-something laundromat owners establish "read and learn" areas in their facilities; college students; an 8-year-old girl using the LLL to do a 'good deed' for her church confirmation, and of course many retirees who assist in many ways.
- Events included book drives in Berwyn, Elementary schools (Linwood and Mary C. House in particular), a college alumni affiliation group, and a celebration of life for a support yielded a supply of books.
- A Women's History Month book list was developed and, through an AAUW grant among other sources, was filled and books delivered to area laundromats in time for that event in March.



- A book display and giveaway were held at the Melton Center in West Chester for the Juneteenth celebration in June, promoting literacy and the Laundromat Library League as well.
- A milestone event was also reached in June when 1,000 books were selected, packed and distributed by the LLL in just five days.
- Over 300 Holiday themed books were sent out in small batches to supplement laundromats around the region.
