

Sustainability in Chester County: October Meeting

Rachael Griffith, Chester County's
Sustainability Director, spoke to a very
interested audience at the October meeting. She
outlined the County's Sustainability staff and
resources under the Chester County Planning
Commission, in a talk entitled "Bringing
Sustainability Home: County Policy, community
action, and each of us."



She provided details on several important components of the program which began several years ago. Rachael outlined the County's Climate Action Plan, the goal of which is to reduce greenhouse gas emissions by 80% of 2005 "levels by 2050. She noted that "achieving an 80% reduction by 2050 will require significant reductions in most emission

sectors and dramatic changes in the economic polies and consumer preferences." The Climate Action Plan is directed at reducing emissions from County operations primarily from buildings and stationary energy sources, looking to use solar, e-vehicles, and improved waste management and agricultural practices.

At the county-wide community level emissions mainly come from transportation energy, commercial and industrial energy, and residential energy. Among some Climate Action measures, Rachael described advancements in the community-wide trail system for walking and biking. She noted promotion of solarization of residences in Southeastern PA, describing federal grants. She noted a program to assist HOAs, which include a large portion of County home properties, to promote sustainable practices. And finally she noted what we as individuals can do, for example, in our yards, catching the rain with native plant gardens that support pollinators and biodiversity.
